Note: Initiation **Fees, Membership Dues and Capital Assessment Fees are non-refundable flat rate assessments. Membership is not transferable to adult children, relatives, friends or co-owners of a boat. Only moorage members may operate a boat within the marina or use a gate card. One membership is defined as a person who has attained the age of 19 and may include a spouse and children under 19 years of age. All other family members or friends would need to become members in order to operate a boat within the marine or use a PYC gate card.**

MOORAGE:

PYC Marina is located at 5667 Beach Avenue, Peachland, B.C.(the 8th Street Marina). Sixty (60) slips are available for:

- Sailboats (minimum length 15 feet, maximum overall length 33 feet, maximum beam 11 feet)
- Power boats (Outboard or Inboard/Outboard, 15-33 feet in length, max. beam 11 feet, minimum 40 hp)

PYC regrets that we cannot offer moorage for Houseboats, Pontoon boats, Twin-hull boats, Personal watercraft, or car-top boats such as canoes, kayaks or aluminum fishing boats. Thru-transom exhaust systems must have a Captain's Call switch. Moorage is managed by the Fleet Captain and is filled from the Wait List based on "Next in Line". When permanent, sublet or day moorage becomes available, you will be required to fill out a Moorage Contract and provide proof of insurance. If the boat you own or are contemplating acquiring is an uncommon size, moorage will depend on:

(a.) Size Space Availability

(b.) Member's Current Moorage status and allocation

(c.) Confirmation of Annual Dues payment if on the Wait List. If space is not available for your size of boat, moorage may be delayed pending a vacancy in that size category. Your name remains on the Wait List Register.

Permanent Moorage:

- A Qualified Wait List Member ***IS OBLIGED to accept PERMANENT moorage*** when offered.
- If a Qualified Wait List Member declines permanent moorage, the Member's current rank on the Wait List will be forfeited, and the Member will be moved to the bottom of the list.

Sublet Moorage:

- A qualified Wait List Member ***is NOT OBLIGED to accept TEMPORARY moorage*** when offered.

Daily Moorage:

- At times, Moorage members may need to remove their boats from the Marina for repairs or other reasons.
- If daily moorage becomes available due to a temporary vacancy, the Fleet Captain will offer it to Wait List members who have a boat that will fit the berth, based on "next in line". There is no obligation to accept.
- The Executive will set the rate for daily moorage rental.

GATE CARDS:

A **Member** in good standing is eligible for a Gate Fob to access the Marina.

- A deposit of \$30.00 per card (maximum 2 per family) is required and will be refunded provided that the Gate Fob is surrendered, ***undamaged***, to the PYC Treasurer at the above address within 30 days of cancellation of Membership. Failure to apply for a refund and surrendering an undamaged card within 30 days will result in the \$30.00 deposit being forfeited to the PYC.
- ***Gate cards are not transferable*** and are for Moorage Members' use only, as per the Gate Card Contract.

GUEST MOORAGE AT OTHER YACHT CLUBS:

If you have moorage and plan to visit other valley yacht clubs by water, please contact the other yacht club ahead of time to make arrangements. Proof of moorage and liability insurance will be required.
